## 36 dwellings beside Goldsborough Cricket Club

The applicant has submitted a revised scheme to HBC Planning. It now has its main access to the north of the site and coming in off Station Road and the lane up to Cockstone Farm. There will be a short presentation on this new scheme on behalf of the applicant at our July Meeting and HBC will require comments on the Planning Application no later than the very next day i.e Tuesday 10<sup>th</sup> July 2018.

## **Proposed large local housing developments**

Since December 2017 an Outline Planning Application has been lodged with HBC Planning for a proposed (up to) 2750 housing development at the old Flaxby Golf Course. HBC have not responded on this yet. Last week CEG submitted an outline planning application for its (up to) 3000 home development at Green Hammerton. We understand shortly the Oakgate Group will be submitting its own outline application for a similar size 3000 home development called Maltkiln Village near to Cattal. For those of you who would like to comment for or against the Green Hammerton development please do so now (or no later than 29<sup>th</sup> June) via the HBC Public Access website or write in to HBC Planning.
